PRNJAVOR MUNICIPALITY OVERVIEW OF SITUATION IN PRIORITY SECTORS 2018

METAL PROCESSING

- 15 of 236 SMEs do business in metal processing (6.4%).
- In comparison to last year, along with current leaders in the metal processing sector, it is notable the breakthrough of new companies in the market, successfully doing business in the territory of the Prnjavor Municipality (Armako d.o.o., Topinox d.o.o.).
- 13.8% of all employees in the economy in the territory of the municipality works in this sector.
- In most of key parameters in the metal processing sector there may be noted positive trends and growth rate in the period 2015-2017.
- The metal processing sector accomplishes 38.6% of its total income from export.
- Five major SMEs in the metal processing area employ 76% of the total number of employees in this sector.
- Average net personal income in the metal processing sector amounts to BAM 736 and is higher by 6.97% of the average salary in the Prnjavor Municipality (BAM 688).

- In 2017, 15 companies submitted their financial statements to APIF.
- In 2017, there were 102 employees more in the metal processing sector than in the year before. Some of key employers (e.g. DIS EUROSTANARD) hired many new employees in this year.
- Total income increased by BAM 11.5 million in comparison to the previous year (12.8%).
- Total income per employee reduced by BAM 9,111.
- Share of income in the metal processing sector in the total income of SMEs in the Prnjavor Municipality in 2017 amounts to 14.6%, which is almost the same share as in 2016 (14.5%).
- Profit in the metal processing sector increased by BAM 363,425 in comparison to 2016 (by 3.5%), but due to significantly higher number of employees in 2017, profit per employee reduced by BAM 116 in comparison to 2016.
- Export in the metal processing sector increased by BAM 3.94 million in comparison to 2016 (9.7%).
- In this sector a great deal of income is still generated from export (38.55% in 2017, in comparison to 28.7% in 2016).

- In 2017, all key economic operators in the sector continued expanding their international market. Share of export accomplished in the metal processing sector in the total export of Prnjavor amounts to 19.8%, which is 1.5% more than in the year before.
- Metal processing sector employs 13.8% of all employees in the territory of Prnjavor (by 1% less in comparison to 2016).
- In 2017, average gross salary in this sector increased by 7% in comparison to 2016, while net salary increased by 18.7%.
